**RE: INQUBO YOKUHLOLA EYISISEKELO, UHLELO LOKULAWULWA KOKULUNGISA NESICELO SELAYISENSI YOKUSETSHENZISWA KWAMANZI EKWAKHIWENI KWENTAMBO KAGESI YESIKHASHANA IMPALA ZIRCON TEMPORARY BY-PASS 132KV POWERLINE KANYE NENGQALASIZINDA EHLOBENE NAYO KANYE NOKULUNGISWA KWENTAMBO KAGESI EYINHLOKO IMPALA ZIRCON 132KV MAIN POWERLINE EKHONA KUMASIPALA WASEMHLATHUZE KWAZULU-NATALI.**

U-Eskom SOC Limited (umfaki sicelo) uhlose uKulungisa Nokuthuthukisa intambo kagesi Impala Zircon 132kV Powerline ephakela ugesi amakhasimende abalelwa ku-6062; kodwa-ke, ngenxa yokuthi iseduze nogu lolwandle, le ntambo iwohlozwa umswakamo futhi iyonakala. Ngakho-ke, umfaki sicelo uhlongoza ukwakha iNtambo Kagesi yesikhashana engu-6.01 km i-132kV Bypass Powerline esebenzisa izigxobo okuthiwa i-Triple Wooden Pole Structures, ezizosetshenziswa iminyaka emithathu ukuze kube nethuba lokulungisa nokuthuthukisa iNtambo Kagesi Eyinhloko. Le ntambo yesikhashana izohamba iqondane nentambo eyinhloko ekhona, zihlukaniswe cishe u-15m futhi ziwele uMfula uMhlathuze.

Lokhu kungenxa yemisebenzi ezodinga ukuqaliswa eSazisweni Sokusohlwini 1 no-3 ngaphansi kweZiqondiso Zokuhlola Komthelela Kwezemvelo (EIA), 2014 (njengoba zichitshiyelwe). Ngakho-ke, kuzolandelwa inqubo yoKuhlola Okuyisisekelo.

Ngaphezu kwalokho, kuzokwenziwa uHlelo Lokulawulwa Kokulungisa (Maintenance Management Plan [MMP]) oluqondene noKulungiswa Nokuthuthukiswa kweNtambo Kagesi Eyinhloko Ekhona. I-MMP izokwenziwa ngokuvumelana neZiqondiso Ze-EIA, zika-2014 (njengoba zichitshiyelwe) ezethulwe ngaphansi koMthetho Wokulawulwa Kwezemvelo Kuzwelonke, 1998 (uMthetho No. 107 ka-1998), ngokuqondile ukuze kuhlangatshezwane nezimfuneko zeSigaba 28 se-NEMA, esihlobene nomthwalo wokunakekela nokulungisa.

Okokugcina, kudingeka iSicelo Selayisensi Yokusetshenziswa Kwamanzi (WULA) ngoba lokhu okuzokwenziwa kudinga iSigaba 21 soMthetho Wamanzi Kazwelonke, ka-1998 (uMthetho No. 36 ka-1998) (NWA) kanye neZiqondiso Zokufakwa Kwezikalazo ezihlobene nawo, zika-2017 (njengoba zichitshiyelwe).
